RESOLUTION REMOVING CERTAIN CONNECTING LINK STREETS FROM THE COUNTY ROAD SYSTEM

WHEREAS, pursuant to K.S.A. 68-506, it is the duty of the Board of County Commissioners, with the approval of the County Engineer, to classify roads and highways within Sedgwick County; and

WHEREAS, pursuant to K.S.A. 68-506f, it is the duty of the Board of County Commissioners, in the absence of an agreement between Sedgwick County and any city having a population of less than 5,000 which is located within Sedgwick County, to maintain connecting links in the county road and highway system; and

WHEREAS, there is not an agreement between Sedgwick County and the City of Goddard regarding connecting links; and

WHEREAS, certain connecting links within the city limits of Goddard have been maintained by Sedgwick County as connecting links under the authority of K.S.A. 68-506f; and

WHEREAS, the 2020 U.S. Census indicated that the population of Goddard is now 5,000 or greater; and

WHEREAS, said connecting links are no longer subject to K.S.A. 68-506f and should be removed from the Sedgwick County Road System; and

WHEREAS, pursuant to K.S.A. 19-101a(b), this resolution shall take effect upon publication.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

SECTION ONE: The Board of County Commissioners finds and determines that the City of

> Goddard, Kansas has a population of 5,000 or more, and that, for such reason, certain streets located within the city limits of said city no longer qualify as connecting links within the Sedgwick County Road System.

SECTION TWO: The following connecting link streets within the city limits of the City of

Goddard, Kansas are hereby removed from the Sedgwick County Road

System:

- A. 6th Street South (Maple Street) between 167th Street West and 199th Street West
- B. 23rd Street South between 183rd Street West and 199th Street West
- C. 199th Street West (Goddard Road) between 6th Street South (Maple Street) and 31st Street South

SECTION THREE: This resolution shall become effective upon its publication.
