- I. Welcome, Announcements & Introductions Chair Brian Powers
  - a. Chair Brian Powers called the meeting to order with a quorum present.
- II. Meeting Minutes
  - a. Motion made by Virginia Zapote to approve April 2024 minutes; seconded by Stacey Fuller. **11-0.**
- III. Monthly Updates
  - a. Transportation Committee
    - i. An RFP has been issued for new transit center construction
    - ii. Collecting feedback on the redesign through May 31
    - iii. Board will be invited for a tour once the new transit center is built
- IV. New Business
  - a. Wheelchair-accessible transportation discussion
    - i. Maria Salas, Sunflower Health Plan: Sunflower has new value-added benefit for three free rides for social/nonmedical transportation this

- year; will consider feedback about further needs in annual value-added benefits review
- ii. Tim Thomas, United Healthcare: UHC has had value-added benefits for a few years; started with 12 round-trip rides, last year increased to 24 rides
- iii. Melissa Rogers, Aetna Better Health: Aetna Better Health also has valueadded benefits and offers extensive mileage reimbursement for rideshares and similar services.
- iv. Karen Flateau shared that she has not found any Lyfts or Ubers that have accessible vehicles in town; cost is prohibitive for them
- v. Information regarding value-added benefits can be found through the state insurance website and each provider's website.

### b. INTRUST Bank Arena updates

- i. AJ Boleski shared that they have a presentation on the accessible website features prepared for next month's meeting.
- ii. Virginia Zapote shared that there are some concerns about lines forming outside Orpheum blocking access paths.
- iii. AJ Boleski said that they generally try to keep lines up against the building; he will make sure this is happening beginning with shows tonight
- c. Accessibility guidelines for pedestrian facilities in the public right-of-way
  - i. Tabling topic until after June National Federation of the Blind meeting
- d. Disability waiting list letters: Board of County Commissioners and City Council
  - i. Chair Brian Powers read the letter aloud to the board
  - ii. Shelley Herrington noted that some of the numbers have changed since the letter was drafted: the state is providing funding to alleviate the wait for 500 individuals, not 250; the list will be capped at 4,800, not 6,800
  - iii. Motion made by Tom Page to empower the Chair to do any statistical updating necessary and continue with the letter; seconded by Karen Flateau. **15-0.**

#### e. Chair nominations

- i. Andrew Crane nominated Tom Page; Tom Page declined but would consider serving as Vice-Chair.
- ii. Brian Powers nominated Lisa Vayda (absent). Kyelene Flaming seconded the nomination.
- iii. Members may consider other nominations and present them at next month's meeting before the board votes on the position.

- a. Andrew Crane: Guiding Paws event at Wichita Wind Surge game on May 30
- b. Tom Page: Tom attended the Board of County Commissioners meeting to be sworn in for another term representing District 4 on the board. He will continue to look for a member to hold the seat reserved for the National Federation of the Blind.
