- I. Welcome, Announcements & Introductions Chair Brian Powers
  - a. Chair Brian Powers called the meeting to order with a quorum present.
- II. Meeting Minutes
  - a. Motion made by Kyelene Flaming to approve April 2024 minutes; seconded by Raven Alexander. **12-0.**
- III. Monthly Updates
  - a. Transportation Committee
    - i. The redesign consultant recapped the stakeholder meetings from June.
    - ii. The bids for the new transit center construction ended on the 21<sup>st</sup>. Bids are being reviewed.
    - iii. Brian Powers: were there any handsout regarding the budget.
    - iv. Raven Alexander: no, there were no handouts. The concept is based on the current budget.
- IV. New Business
  - a. Orpheum Theater Renovations Plan
    - i. Luke Scott, WDM Architects: Presented proposed design options for accessibility in the seating area on the ground floor.

- ii. Brian Powers: How does the stair step configuration provide access throughout the theater?
- iii. Luke Scott: It does not provide access to the front of the theater. What it does is fix the steep slope between the front and back. There is no way to get a path to the front for wheel chair accessibility.
- iv. Andrew Crane: Will there be the required 36 inches of space for service dogs next to the accessible spaces?
- v. Luke Scott: Can you point us to the section of the ADA manual where this requirement is found?
- vi. AJ Boleski: In the accessible area, will the companion seats be fixed seats or folding chairs?
- vii. Luke Scott: That has not yet been decided, but leaning towards folding chairs.
- viii. There is no accessible seating in the balcony, no space to add an elevator.

### b. INTRUST Bank Arena updates

- i. Showed a demo of the update to the website for screen readers.
- ii. Andrew Crane: this still does not work with certain screen reader smart phone apps.

#### c. Riverfest Debrief

- i. Nate Johnson: it was much easier going through the carnival part as all the cables had been moved to the sides.
- d. Sedgwick County Proclamation for ADA Day
  - i. Proclamation has been done for the last few years. Board agrees to submit request for 2024.
  - ii. Kyelene Flaming: In the past we've sent a request to the City of Wichita as well. Sabrina has a link to the website for ADA logos that others can use. Will be sent out with the July agenda.
  - iii. Kyelene Flaming: July is also Disability Pride month.

#### e. Chair nominations

- i. Lisa Vayda declined the nomination made in May.
- ii. Kyelene Flaming: it should not be anyone directly employeed by Sedgwick County or the City of Wichita. It should be someone from an agency. Can we get a list of all voting members and their attendance?
- iii. No new nominations were made. No vote taken.

- v. Members may consider other nominations and present them at next month's meeting before the board votes on the position.
