Apex Sketch sketching software is used in conjunction with the state mandated Computer Assisted Mass Appraisal (CAMA) system, Orion. This software allows the Appraiser's Office to sketch outlines of every improvement in the county to accurately obtain square footage.

Apex Sketch allows for angles, curves, turrets, other odd shapes, and calculates an exact area of said improvements. If the Appraiser's Office did not have this software, they would attempt to sketch with the sketching package that is part of the Orion software but it does not allow for angles, curves, turrets, or other odd shapes, causing the calculation of square footage to be manually calculated and resulting in errors. In addition, sketches would not be viewable to the public on the Appraiser's website as it would not be part of the property record card.

Apex Sketch has been in use since 2008 and continues to be an important tool utilized by the Appraiser's Office.
