- During the month of February Sedgwick County Developmental Disability Organization (SCDDO) Quality Assurance Staff completed 4 day and 12 residential program visits.
- Dementia Friendly Sedgwick County is the first cooperative initiative undertaken by both the Aging Services and CDDO under the combined Sedgwick County Department of Aging and Disabilities. A second meeting of the Action Team was held in February. The Team is working on developing surveys to provide a baseline of knowledge about dementia for governmental and intellectual/developmental disability (IDD) staff. With the survey information, The Action Team will begin planning activities and/or training. Our goal is to foster community support for people living with dementia and their essential caregivers, so they can safely remain and continue to engage in the community.
- The bi-annual KDADS CDDO Stakeholder Meeting was held in February. KDADS provided updates on waiting list offers and the Community Support Waiver. There was significant conversation around new HCBS Settings Final Rule training requirements, as well as documentation requirements for IDD system eligibility.
- Independence, Inc. became an affiliated provider in Sedgwick County in February. Independence, Inc. provides
  financial management services and helps individuals self-direct their services. The company has been in Kansas
  and providing waiver services for many years.
