- I. Welcome, Announcements & Introductions Brian Powers
 - a. **John Crane Goals:** People with disabilities should be treated like every other citizen and not second class citizens.
 - b. **Susie Ternes Goals:** Continue to advocate for the deaf and hard of hearing community.
- II. Call of the Meeting Attendees A quorum was present.
- III. Meeting Minutes
 - a. Motion to approve Approval April 2025 minutes made by Brian Powers; seconded by Andrew Crane. **Passed 20 with 1 abstentions.**

IV. Public Comment

Finn and Aggie joined us as the youngest visitors of the meeting. Stacy Rogers, a SDCO disability board member and candidate for Governor attended the meeting. Parking for the access advisory board is east of market in the empty lot.

V. Monthly Updates

a. ADA Staff Updates – Mike Armour.

A federal funding opportunity grant application is due on June 26th. This grant will be used to improve 37th St N to Pawnee. This section has higher crash rate, and higher than average use by pedestrians, bicyclists and others. These funds will be used to include ATS, ADA upgrades along the corridor for motorist and pedestrians. A consultant is looking into redesigning the section into 3 lanes + bike path. There will be limitations based on areas of high need vs low need. A letter of support from organizations can improve our selection rate. Currently, only 10% of applications are approved. We are requesting 20 million but there is a chance we could receive a partial amount. We will be coming back to the board with designs for feedback and suggestions.

The WSCAAB will write a letter supporting the federal grant application for Safe Streets and Roads for All. A motion in favor was made by Lloyd Hanna; seconded by Tom Page. The motion passed 21 – 0 with 0 abstentions.

b. Subcommittee report – Lisa Vayda, Andrew Crane, Tom Page
All edits to be submitted to Michelle who will forward it to the sub-committee.
Need to take out specific names like Nate Johnson, Dion Leffler and aim for a
more positive, solution based resolution rather than point fingers at people.
The incoming city manager, officials, elected need to know exactly why we are
bringing this up and know exactly what we are upset about. We are asking the
elected to conform to the best practices rather than just follow the law.
Call your councilperson and express your opinion. Alternately, board members
need to have these conversations with the officials that nominated them onto
the board. There are several gaps in communication and part of the issue is with
people not stepping up and participating in events that are collecting feedback.
The city and county are required to issue public notices, contact stakeholders,
and engage with the press on these topics, however, the general public chooses
not to engage in these opportunites.
