On the recommendation of Lee Barrier, on behalf of the Sheriff's Office, Anna Meyerhoff-Cole moved to **accept the quote from Cox Communications Kansas, LLC and/or Cox Kansas Telecom (Cox Communications Kansas, LLC) in the amount of \$56,760.00 for a period of 60 months.** Brandi Baily seconded the motion. The motion passed 4 to 5 with Tim Myers abstaining from the vote.

This is a replacement data line for the Sheriff's Squad Room. This line needs to be replaced for two (2) reasons:

1. The existing line is being shared with multiple other county agencies such as Noxious Weeds, EMS, Fleet, etc. and does not have enough bandwidth.
2. The manner in which the original line was installed in the Squad Room is flawed and has already failed due to rain getting into the conduit and will fail again in the future if not replaced.

Notes:

The Public Safety Building is the dedicated secure link between the two (2) locations and is used to extend the network and provide internet access to remote locations.

On the recommendation of Britt Rosencutter, on behalf of Fleet Management and Sheriff's Office, Philip Davolt moved to **accept the lowest bid meeting specifications from Don Hattan Chevrolet in the amount of \$93,856.00**. Brandi Baily seconded the motion. The motion passed 4 to 5 with Tim Myers abstaining from the vote.

These vehicles will be used by Sheriff's Warrants deputies for their everyday tasks.

Davis Moore had a lower price but did not meet specifications on two (2) items. Fleet and Sheriff's Office specified cloth seats, Davis Moore quoted vinyl. Fleet and Sheriff's Office specified three (3) sets of keys per vehicle and Davis Moore responded "not available".

Notes:

Fleet evaluates all vehicles and equipment up for replacement before requesting bids.

Questions and Answers

Philip Davolt: The question I have is, I see that you're replacing two (2) cars with two (2) trucks available?

Beau Bergeron: Yes. We can't get police package cars anymore. Nobody's making one right now and they want a variety of different vehicles to test with.

Tania Cole: So can you just explain on the specification why the cloth seats?

Beau Bergeron: So this is actually a two (2) part deal. This RFP is for two (2) and then we had another one for just one (1) because they want a mix. We went with two (2) here because for one, the cloth, it's more comfortable. They're going to be sitting in these things all day. It holds up better. Then the keys, they couldn't do fleet key or key alike or the any extra keys we get are usually \$400.00 a piece. So by doing the low bid on the one (1) that didn't meet spec, we were able to get what we needed on these two (2). So we still had to split it, but by this way, ideally, we would have gone with a little bit on both but we needed a variety and only two (2) manufacturers bid. Otherwise we would have gone with one (1) of each.
