SCAC met at 9:00 AM on Saturday, May 10, 2025, in the Hubbard Arts Center.

Mayor Coleman presided. SCAC members and visitors are shown on the attached list.

#### Welcome

- Mayor Ashley Coleman (Kechi) welcomed all members and guests to the meeting. All attendees introduced themselves.
- City Manager Kiel Mangus (Derby) gave a small update about the City of Derby.
  The city received a WAMPO grant for redoing the access to Walmart, currently
  building a new senior center, and entered phase 2 of a new park. A lot of new
  development is going on in the city.

### **Approval of Minutes from March 8, 2025**

**ACTION TAKEN:** Motion by Mayor Jim Benage (Bel Aire) to APPROVE minutes from May 10, 2025.

# **Approval of Treasurer's Report**

Council Member David Guo (Maize) presented the June 30, 2025, Treasurer's Report. With an ending balance of \$12,605.43.

**ACTION TAKEN:** Motion by Council Member Gina Gregory (Valley Center) to APPROVE April 30, 2025, Treasurer's Report.

Seconded by Mayor Tracy Pribbenow (Bentley). Motion passed unanimously.

### **Stormwater Quality and Quantity Regulations**

Sedgwick County Senior Engineer Scott Lindebak and County Engineer Lynn Packer gave a presentation on storm water cooperation and regulations.

They emphasized that there are 34 small watersheds throughout the county, everyone drains into each other, and there are around 1450 miles of streams in Sedgwick County.

The county tried to create a county-wide set of regulations for storm water management in years past, but were unable to get buy-in from cities due to competition for development. They also emphasized that the best time to complete storm water projects is during drought.

The Sedgwick County Storm Water Advisory Board (SMAB) developed plan for getting a county-wide set of regulations and analyzed projects that needs to be addressed in Sedgwick County and found \$500 million worth of projects needing to be addressed.

Sedgwick County Public Works is hoping to develop a dedicated funding source and regional system for addressing storm water as opposed to individual and siloed systems. They had talks with KDHE about a regional system of credits for EPA certification.

### **Vote to Move November Meeting**

**ACTION TAKEN:** Motion by Mayor Jim Benage (Bel Aire) to MOVE November meeting date to November 15, 2025.

Seconded by Gina Gregory (Valley Center). **Motion passed unanimously.** 

# **Sedgwick County Update**

Sedgwick County Commissioner Jim Howell gave the update.

The proposed budget is up and online comments are available, but they currently only have four comments. The best chance to give public input on the budget is at the July 30<sup>th</sup> meeting. There was an assessed value growth of 8.6%, but the budget only captures 5.5% of the growth. Solid waste and MAPD fees are changing this year as well.

There is a new exercise area at Sedgwick County Park going in for the elderly and folks with disabilities. This is possible due to an \$180,000 grant.

The County Appraiser is retiring and so there will be a new appraiser hired in the future.

Finally, the county is in the process of due diligence on the Envision Building to be used as the county's admin building.

# **Around the County: City and Other Reports**

- Valley Center South entrance and the roundabout are now open. Water treatment plant is coming soon, and a new school was just built.
- Elections small primary election soon. Getting a new building, but don't know when they are moving.
- Maize Sales tax question is on the ballot and there is a new slogan for the City.
- WSU HWS WSU can help with funding mechanism questions for storm water and they have finished the move to the third floor of Lindquist.
- Goddard Getting a lot of new roundabouts and some turn lanes are getting finished.
- Bel Aire Rock is closed, but should open in about a week. They will close Oliver soon after Kechi finishes their construction. There is also a bridge replacement coming soon.
- Mulvane Main sewerline project is still under development. The old settlers is coming up, and the County Fair is currently ongoing.
- Haysville Market is open, and 45<sup>th</sup> annual city wide garage sale is coming up.
- Derby \$35 million wastewater expansion and water treatment plan are going into effect. Recently got a .gov website and recommends everyone switch over to a .gov website.
