On the recommendation of Tammy Culley, on behalf of Fire District 1 (SCFD1), Philip Davolt moved to **accept the quote from Masimo in the amount of \$110,540.00**. Brandi Baily seconded the motion. The motion passed unanimously.

The Masimo Rad-57 handheld device allows SCFD1 crews to quickly ascertain oxygen levels, carbon monoxide levels, and heart rate in medical patients. SCFD1 is the only responding department in the county that deploys this capability on all medical responses.

The Rad-57 is the only handheld device with this functionality. Other devices that can determine carbon monoxide levels are larger and significantly more costly. Replacing our current Rad-57 devices will allow SCFD1 to maintain the same level of service that is provided today. The device is used on almost all medical responses when SCFD1 performs patient care.

Questions and Answers

Brandi Baily: Are we replacing all the devices and if so, what's the life expectancy of the devices?

Jonathan Halley: We are replacing all the devices. Typically, we look at an eight (8) year replacement life. We're getting into nine (9) or 10 years now and so it's time to replace them.

The motion passed unanimously.

These vehicles are used by SCFD 1 staff to respond to and investigate fires within the county as well as perform inspections and other job related duties.

Parks Motors and Davis Moore have lower bids but do not meet the specification on the drivetrain. The specification was set at a minimum of a 6.6 liter engine due to the history SCFD 1 has had with the 6.4 liter Hemi's reliability.

Questions and Answers

Philip Davolt: Is this price from the low bid, is that delivered here to Sedgwick County?

Brian Richey: It is.

Philip Davolt: I couldn't tell, is that a four-wheel drive truck?

Brian Richey: Yes.

Philip Davolt: In looking ahead, The next bid has also another truck in it and it's higher. What's the difference between the two (2) price differences?

Brian Richey: The price for two (2) is for short bed vehicles. The second truck is for a long bed vehicle, which the training officer needs to carry more gear in. That's the difference between the two (2) bids. They're both crew cab vehicles, just the bed on the backs are different.

Philip Davolt: Can you explain this difference between the 6.6 that makes you like it better than the 6.4?

Brian Richey: Well typically we try to keep our wheelbases as short as we can, just for maneuverability. That's currently what we run and probably 90% of our staff vehicles is the crew cab short bed, but our training officer felt that he needed a longer bed to store the tools in the longer bed.

Philip Davolt: You couldn't accept the other lower bids because of the specification of a 6.6 liter engine versus a 6.4?

Brian Richey: That difference is we've had some 6.4 liter Hemi motors from the Dodge product and other county vehicles, including our own, that we haven't had very good luck with. We've had camshaft issues, fairly major engine, and transmission issues. That's kind of why we set our standard at the 6.6. Not to eliminate, they could be at a 6.7, or a diesel version that hasn't incurred those same problems. So, that's kind of why, I mean, we feel that this 6.4 liter Hemi. Over its lifetime ownership would cost us a lot of money to keep on the road versus the other two or the other motor that we specified. That's just our opinion.
