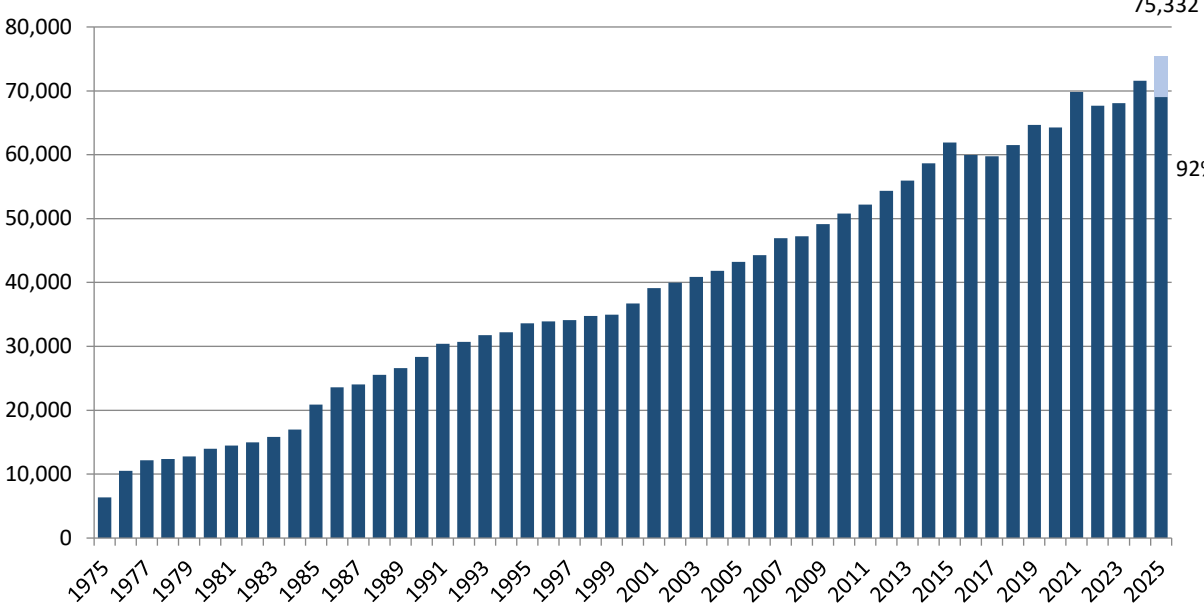

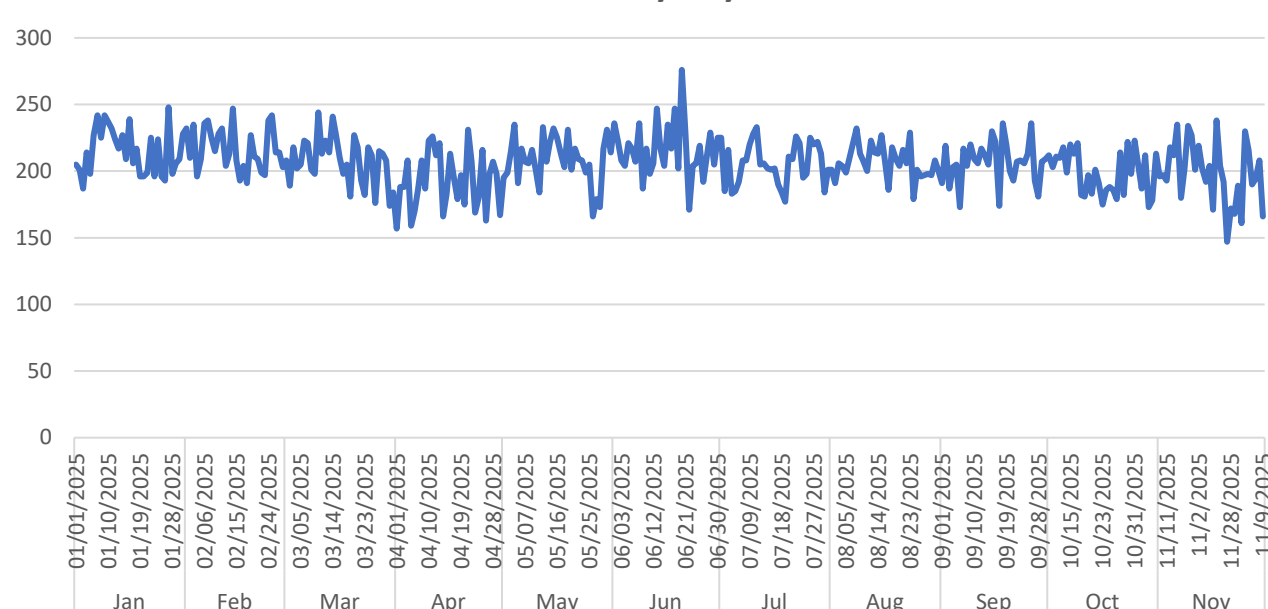

Annual Call Volume

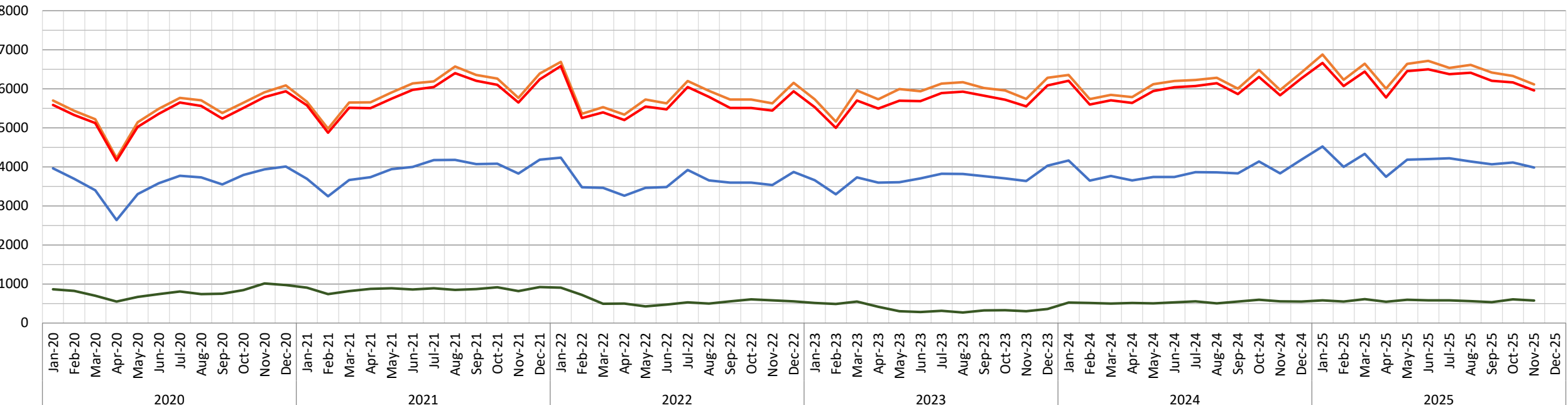


Calls by Day

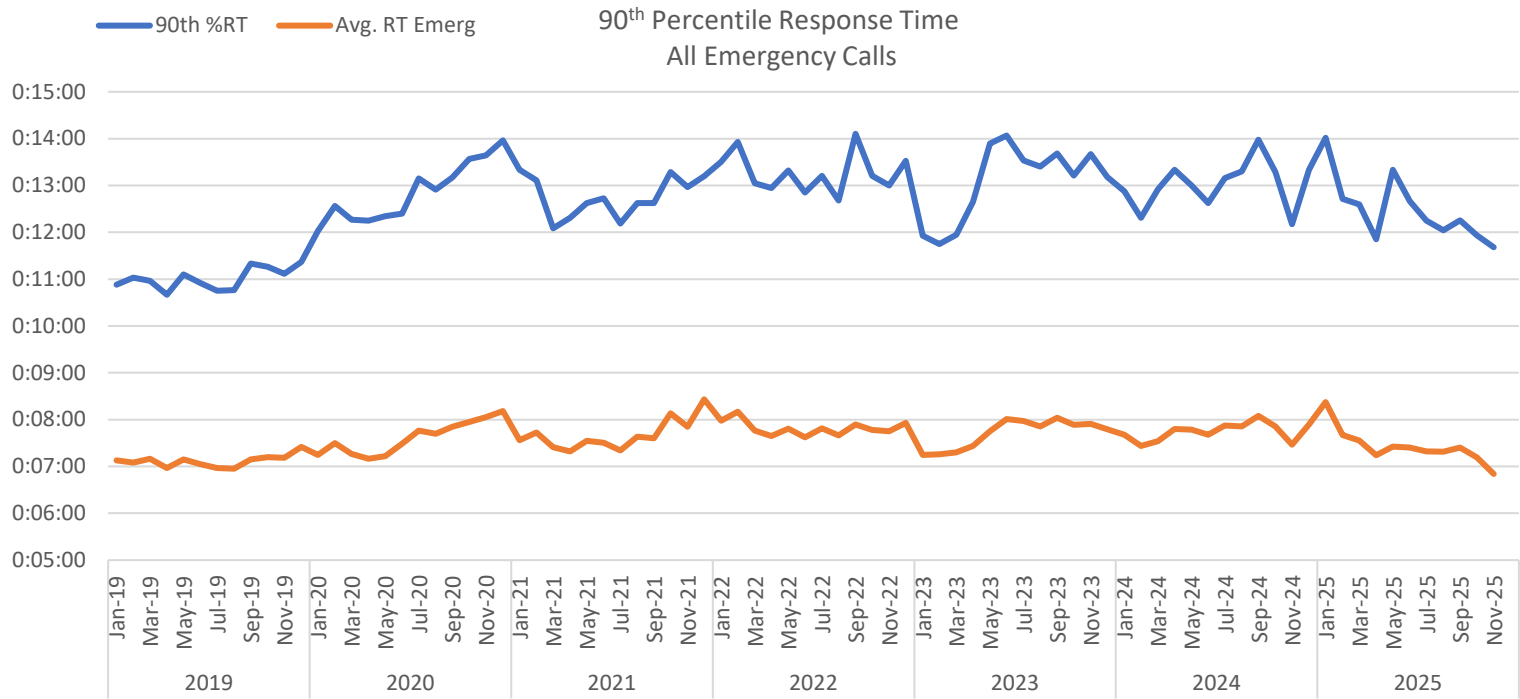

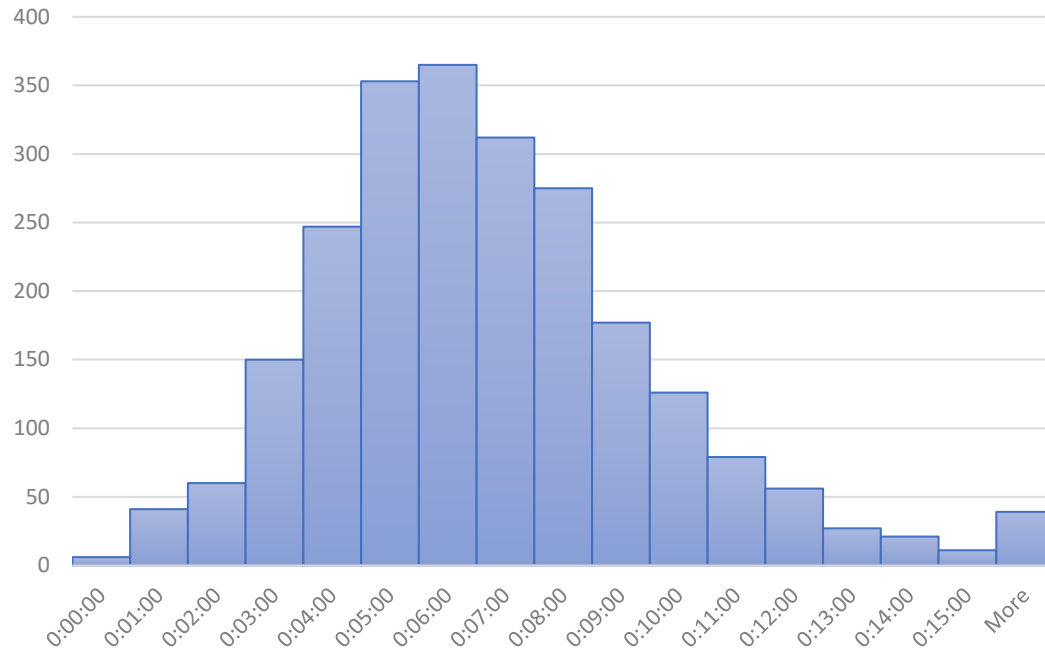

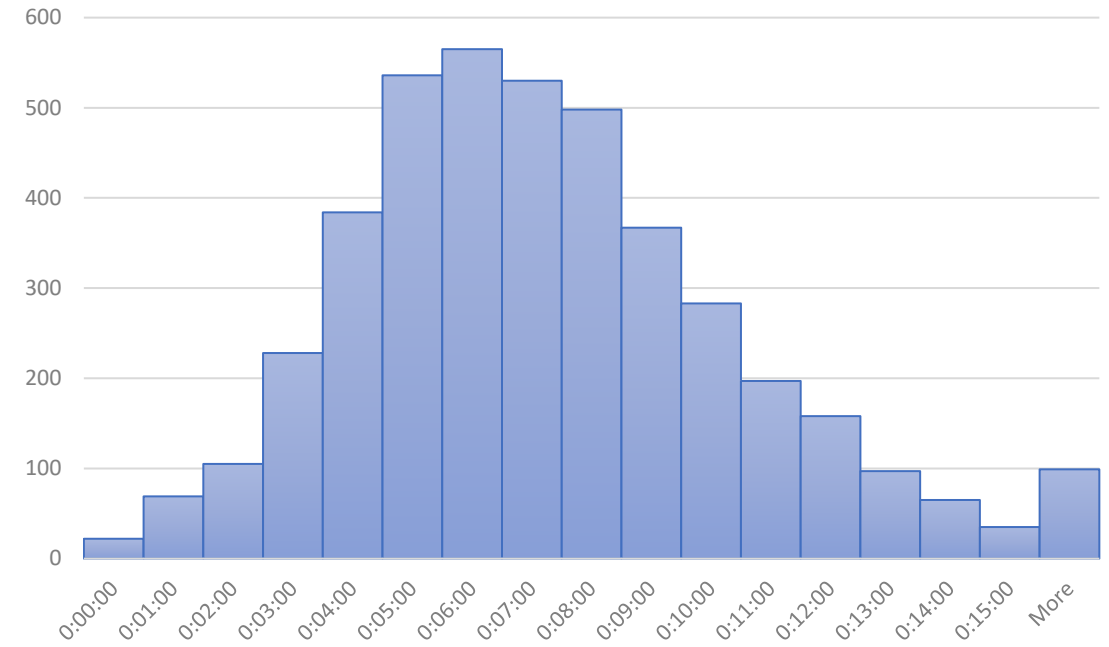


P1 - 2 Response Time (RT), November 2025

Response times (RT) are measured from dispatch to arrival on scene. EMS responds to calls using lights and sirens on Priority 1 and 2 emergency calls only, which was 55% of emergency calls in November.

Produced Unit Hours = 12,308 (100.6%)

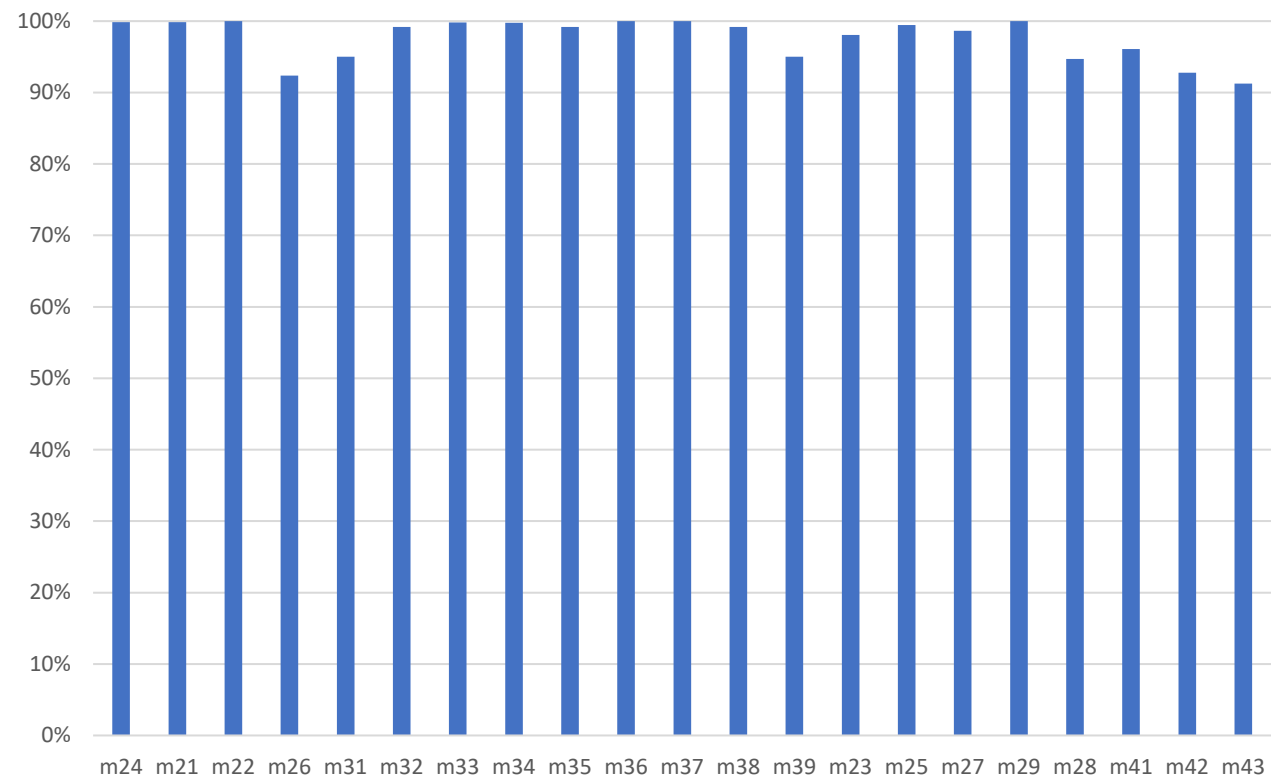
