On the recommendation of Tammy Culley, on behalf of the Department of Corrections, Philip Davolt moved to **accept the proposal from Hope in 3-D at the rates listed above good through June 30, 2027.** Anna Meyerhoff-Cole seconded the motion. The motion passed unanimously.

An evaluation committee comprised of Julee Meslin, Lanora Franck, and Larry Burks - Department of Corrections; Phuc Bui - COMCARE; and Jaimee O'Laughlin - Purchasing evaluated the proposal responses based on criteria set forth in the RFP. The committee unanimously agreed to accept the proposal from Hope in 3-D.

This Request for Proposal seeks qualified agencies or organizations to utilize funding from the Kansas Department of Corrections (KDOC) Evidence-Based Programs Funding to deliver educational instruction and classroom support to juvenile offenders participating in the Sedgwick County Department of Corrections Evening Reporting Center. These services are intended to support positive youth development and promote improved educational outcomes for youth by providing certified teaching staff to facilitate classroom activities and educational supports.

This initiative is grounded in the Juvenile Justice Reform Bill enacted in 2016, which restructured the state's approach to serving justice-involved youth by emphasizing prevention, accountability, and evidence-based intervention. As a key component of this reform, the Evidence-Based Programs Fund was established to reinvest resources into community-based programs and practices demonstrated to reduce recidivism and improve long-term outcomes for youth.

Questions and Answers

Tania Cole: I do have a question. I'm just curious. There are a few places where it looks like, Hope in 3-D it's not applicable; Substitute Teacher, Chief Financial Officer, Supervisor/Coach, and Learning Management Software. Just assume that those particular items are not needed but I just want to clarify that.

Jaimee O'Laughlin: Those particular fields weren't items that we asked for as a part of this RFP. I included them because that was part of the items that Prime Fit Youth Foundation budgeted. It isn't what the Department of Corrections was seeking. They were seeking a full-time Teacher and Para. Prime Fit Youth Foundation had these other positions built as a part of their program. I wanted to show all the items that created their total budget for the time period and what we asked for. Those other items or positions weren't what we were seeking ultimately. The other program did include them as a part of their project or their program. So that's why the table read the way that it does.

Tim Myers: Is this a new program for Sedgwick County or did we have a prior vendor?

Mario Salinas: We've had educational services at the Evening Reporting Center for a number of years now with different providers. Each year we get a new allocation, specifically for evidence based program funds. So each year we need to go out for new request for bid or proposal.

Tim Myers: Do we have experience with Hope in 3-D previously?

Mario Salinas: We do not. This is a new provider.

Philip Davolt: Do they provide education that supplements formal education or is this a different kind of education?

Mario Salinas: This education is more or less the feel for those students that are expelled or suspended throughout the school year where they can continue on working through an online curriculum or get assistance for GED prep and those types of things. They don't have the ability to earn a credit through their own platform or something like that.

On the recommendation of Britt Rosencutter, on behalf of the Department of Corrections, Tim Myers moved to **accept the proposal and execute service provider agreement with Mental Health America of South Central Kansas, Inc. in the amount of \$71,574.00 beginning January 1, 2026 and ending December 31, 2026.** Anna Meyerhoff-Cole seconded the motion. The motion passed unanimously.

A committee comprised of Lesa Lank and Julee Meslin - Department of Corrections; Carrie Malin - Division of Finance; Phuc Bui - COMCARE; and Britt Rosencutter - Purchasing evaluated all proposal responses based on the criteria set forth in the RFP. The committee agreed unanimously to accept the proposal as stated above.

The Sedgwick County Community Crime Prevention Fund utilizes current research to target grant dollars to achieve the greatest crime prevention impact and assist youth at risk of offending to improve the quality of their lives. The targeted population includes youth at moderate to high risk for delinquency and their families. The programs funded should provide services that are designed to prevent youth from entering the juvenile justice system or preclude further involvement in the system.

The proposal from Mental Health America of South Central Kansas, Inc. for \$71,574.00 was selected and funded at the full amount requested.

Sedgwick County is allocating approximately \$100,000.00 annually in support of prevention and early intervention programs targeted to youth at risk for juvenile delinquency.

Questions and Answers

Anna Meyerhoff-Cole: Can you explain why one of the components is that the program is not receiving our case from corrections funding?

Mario Salinas: The Kansas Department of Corrections already provides a number of evidence based programing funds for programs throughout the state. So, that was just one of the criteria that they're already receiving funds and have that program out in the community. It was a priority to fund for those that weren't receiving upfront.

Anna Meyerhoff-Cole: It's just to make sure I understand. To summarize, if someone's already getting funding, this helps diversify the different types of programs that can be provided.

Mario Salinas: Correct.

Brandi Bailly: I'm confused on the proposal from Mental Health America of South Central Kansas for \$71,574.00 was selected and funded at the full amount requested. What does the full amount requested mean?

Mario Salinas: The proposal was for that full amount..

Tania Cole: For the \$71,574.00 Mario?

Mario Salinas: Correct.

Brandi Baily: So we're saying we're expecting a full we're going to do everything specifically with this vendor for this full amount. That's just confusing.

Joe Thomas: I think what Brandi is asking, for example, if they requested \$200,000.00, the evaluation committee may have to decide that we're only going to give \$100,000.00. So that's what they are, right Mario? You have discretion. They may ask for a larger amount but you have discretion to do less. You're saying in this case that you took everything.

Mario Salinas: The crime prevention amount, the \$100,000.00. So they submitted their proposals for whatever program they needed, whatever they needed to run their program. And at that MHA proposal, their full amount was the \$71,000.00. If they were to submit a proposal at \$150,000.00, we wouldn't fund that since the allotted amount is only \$100,000.00. The full amount that was requested was the \$71,000.00. So that's what we were able to fund.

Brandi Baily: So you're saying that allocation is \$100,000.00. This is \$71,000.00 so there is still a little bit of money left if we needed to look at something and make sure.

Mario Salinas: Correct.

Britt Rosencutter: In the past, we've also awarded more than one (1) vendor if there's enough funds available. For example, if one of these other programs offered something different, we could fund that program as well but because there's only \$100,000.00 this time, that was the only one that we chose to go with.

Tim Myers: Do we have any experience with Mental Health America of South Central Kansas?

Mario Salinas: They've been a crime prevention funded program for probably about seven (7) years or more now.

Tim Myers: We've been happy with their services?

Mario Salinas: Yes. Their program outcome has been good. Their targeted population capacity is a lot higher compared to the other two (2) programs that were proposed. That's how we were comfortable with moving forward with that program that we were familiar with. That's going to be provided in a number of schools throughout the county.

Joe Thomas: When you see the words Not Accepted, that's on behalf of that particular agency. They're saying, well, we can participate in the requirements under the Senior Care Act but we're not able to participate in the Older Americans Act, whether it's due to how much personnel they have or the type of services that are being offered.

Tania Cole: So you're saying the vendor actually is not accepting not us?

Joe Thomas: That's right. We're accepting all of them because we need as many as we can. Is that right Trista? Monica, you on here? I guess that's the answer.

Philip Davolt: These rates are passed onto the people who use the services?

Joe Thomas: I know that this is the rates that the agencies can charge because that's a set rate.

Philip Davolt: The county doesn't pay those rates though?

The Sedgwick County Sheriff's Office has greatly benefitted from access to this technology and it has enhanced the Sheriff's Office ability to solve crime in Sedgwick County. Without this purchase, the Sheriff's Office will lose access to this database.

Flock cameras are automated license plate readers (ALPRs) used by law enforcement, HOAs, (Homeowners' Associations) and businesses to prevent and solve crimes by capturing vehicle data (plate, make, model, color), not faces, and alerting authorities to stolen cars, wanted vehicles, or suspect cars by matching against hotlists and databases like the FBI's (Federal Bureau of Investigation) NCIC (National Crime Information Center). They serve as a crime-fighting tool to provide evidence, identify suspicious activity, track missing persons' vehicles, and offer proactive alerts for serious offenses like carjackings or robberies.

Questions and Answers

Tania Cole: This is something that the Flock camera access is used pretty regularly with the Sheriff's Office. Is that correct?

Brian White: Yes. Very frequently. Daily.

UKG has confirmed that Workforce Timekeeper (eTimesheet) and Workforce Telestaff are reaching end-of-life with end-of-engineering on December 31, 2025 and full end-of-life on March 31, 2027. Due to these changes, the county must migrate from its on-premise environment to UKG Pro, UKG's cloud-based workforce management platform hosted in Google Cloud. UKG Pro is a software-as-a-service solution (SaaS) hosted in Google Cloud that provides ongoing maintenance, updates with minimal downtime, support, and modern security features such as single sign-on (SSO) and multi-factor authentication (MFA). Remaining on premise is no longer a supported option.

Mosaic Consulting (value added reseller for Vertosoft LLC) is recommended by UKG due to their track record of successfully completed UKG Pro cloud migrations for other government agencies and their Telestaff expertise. Using a vendor with direct UKG experience ensures the upgrade, cloud migration, interface configuration with SAP and Telestaff, and Telestaff assessment and training for Sedgwick County Emergency Management Services and Sedgwick County Fire District 1 are completed efficiently and in alignment with UKG best practices. Utilizing a different or less experienced provider would increase implementation risk and could impact go-live readiness for critical public safety operations.

Questions and Answers

Philip Davolt: Now that we're making this big change, is E-Timesheet still a preferred software for us?

Donna Howerton: The E-Timesheet system that we currently know was actually rebranded as E-Timesheet when we implemented it. It's actually the software called Workforce Central and that is what's going obsolete. We are upgrading to Pro Workforce Management. It's replacing what we know as E-Timesheet.

Philip Davolt: I didn't know if there's other software that can do what we can do and then price or whatever. Is this a good time if you're making a change to make that change now.

Donna Howerton: We have a good relationship with UKG. They're providing all of the needs that we currently have.

Catherine Helms: We're going out for sole sourcing since we currently already have their services. We're just upgrading our services and extending.

Armand Shukaev: Can you clarify Joe that this is not a sole source purchase but a joint government purchase? I just want to make that clear.

Joe Thomas: Yes. In order to get the contract pricing for this particular work, we used a Joint Governmental Purchase. It is a Joint Governmental Purchase based on this OMNIA contract. However, as Catherine said it's a single source, in the sense that we're continuing with the system that we're compatible with. It's no different than SAP. We continue with them because if we had to replace that whole ERP system and go with something totally different, the cost would be exorbitant and waste of time and money. So the same situation exists with our timesheet system, same analogy.

Brandi Baily: The data that's in E-Timesheet right now that we can go run and pull, will that be able to be moved over to the historic data so that we have that for the future or is there a way that we can preserve that?

On the recommendation of Tammy Culley, on behalf of various departments, Tim Myers moved to **accept the quote from UKG (Kronos Incorporated) utilizing the Cobb County, GA - OMNIA Partners Contract #24-6833 good through July 13, 2029 with three (3) one (1) year options to renew.** Philip Davolt seconded the motion. The motion passed unanimously.

UKG has announced that Workforce Timekeeper (eTimesheet) and Workforce Telestaff (scheduling) will no longer receive engineering development after December 31, 2025, requiring the county to transition to UKG Pro to remain on a fully supported platform. UKG Pro is a software-as-a-service solution (SaaS) hosted in Google Cloud that provides ongoing maintenance, updates with minimal downtime, support, and modern security features such as single sign-on (SSO) and multi-factor authentication (MFA).

In addition to the software upgrade, the county's existing timeclock hardware is also approaching end-of-life. Of the county's 57 biometric timeclocks, 56 must be replaced by September 2026. Procuring timeclock equipment, licenses, and ongoing support directly from UKG ensures full compatibility with UKG Pro and provides a single vendor responsible for system performance and support. Utilizing alternative hardware or third-party support would introduce compatibility risks and reduce operational efficiency.

Questions and Answers

Philip Davolt: I noticed the previous one was expiring on September 30, 2028 and this one is expiring July 13, 2029. Since they are similar items, is there a reason for the different dates?

Catherine Helms: The contract with UKG is a continuous one since we'll be using their services and they'll be providing support and then the contract with Vertosoft is just to get us onto the platform. So we will not need their services to be continued passed then.

Brandi Bailly: There's 57 and we're replacing 56 of them? Would it be beneficial to replace all 57 so they're all in the same timeframe.

Donna Howerton: The reason we don't have to replace all 57 is because we currently have one that is the new clock. It was one that was ordered late. Actually, I think we might have two that were ordered later but there are 56 that need to be replaced.
