1. Call to Order & Introductions:

- a. Meeting was called to order at 12:03 p.m. by President Matt Lynch.
- b. Attendance included both in-person and online participants; cited above. Nine voting members were present for a quorum.

2. Action Item: Approval of Minutes

- b. The Coalition reviewed minutes from December 1, 2025 meeting. No corrections were offered. Motion to approve minutes by Heath Bechler, seconded by Tonya LeBrun. Motion carried unanimously.
3. **Action Item:** RFP 25-0084 Finalists and Coalition Recommendation - Joe Thomas, Josh Lauber
 - a. Thirteen proposals were received. Based on cumulative scoring, the top three finalists were:
 1. Rulo Strategies, LLC
 2. The Steadman Group, LLC
 3. Omni Institute
 - b. Questions about RFP and future voting were fielded by Joe Thomas and Josh Lauber in regard to purchasing, and Kirk Sponsel and Armand Shukaev in regard to legal perimeters.
 - Coalition asked about evaluation process and reference checks, and who conducted each.
 - Clarification on KOMA in regard to scoring discussion.
 - Determination of how voting would proceed
 - Clarification on Board's role for majority vote which would then be presented to City and County for approval process.
4. **Other Business:** Request for written references prior to making a final vendor recommendation and vote.
 - a. Motion made by Matt Lynch, seconded by Rena Cole, directing Purchasing to request written references from the top three finalists. Motion carried unanimously.
 - b. Purchasing request references and email them to board members in preface to next meeting.
