Taxes are due and payable on November 1st by Kansas Statute although you are allowed until December 20th to pay without penalty. **At least half of the tax is due by December 20th, and the second half is due by May 10th of the following year.**

If your taxes are paid from an escrow account at your mortgage company or bank, you will receive a statement with tax information on it but your tax bill will be sent to the mortgage company or bank that handles your escrow.
