Overview of Discussions:

The Sedgwick County Fire District One Steering Council meeting was called to order with roll call and the Pledge of Allegiance. Vice Chairman Jeff Witherspoon asked for approval of previous meeting minutes which passed unanimously.

Kent Koehler suggested a consent agenda to streamline meetings.

Jeff Witherspoon and Kent Koehler were elected as chair and vice chair, respectively.

Chief Williams discussed the challenges of aid agreements with cities like Valley Center, Clearwater, and Cheney, emphasizing the need for mutual aid agreements over automatic ones.

The council debated compensation for firefighters. The discussion revolved around the feasibility of a mid-year pay raise, with Chief Williams agreeing to provide detailed budget numbers. The debate was about considering an 8% raise in January 2027 versus a percentage during mid-year 2026 then additional in January 2027 to keep pace with Wichita Fire. The importance of maintaining morale and retention through better benefits and physicals was highlighted.

The meeting concluded with a discussion on the strategic plan and employee feedback. The meeting discussed the participation rate in a vote, which increased from 75-80% to 95% by the six-month point.

The conversation also covered the challenges of transitioning from a 24-hour shift to a 40-hour week for training officers, the impact on training, and the potential benefits of a dedicated training officer.

The council considered the possibility of separating from Sedgwick County, with Commissioners Baty and Howell supportive. Legal and financial implications were noted, including the potential cost savings and the need for a trustee board.

The next meeting is scheduled for July 02, 2026
